"SME 5G Cartography" Position your SME for the upcoming 5G PPP Call 2!

As discussed for some time now the SME WG agreed to try and provide larger organisations with a simple view of what SMEs could do in the 5G landscape –what we called the "SME 5G Cartography". The first step is to position yourself along the "5G pre-structuring model" that has been defined by the 5G Infrastructure Association, and that will serve as an important input to the upcoming 5G PPP Call 2.

We are therefore asking you to look at the attached PPTX file and fill it in as follows:

- On slide 1: select the one or two relevant areas in which your SME can contribute (if you are contributing to more please select the two most relevant ones, three max but no more –otherwise this would not be comprehensible by the people reading it);
- On slide 2: if you are specialized in one or more vertical sectors, select the one or two vertical sectors in which your SME can contribute more specifically (once again if you contribute to more than two just select the two priority sectors for your SME).

Please send the file with the information on your SME to Timo Lahnalampi@interinnov.eu before 15 February 2016.

This information is only a first step for a simple view of what SMES could provide in the 5G domain. This will be complemented by more detailed information that you will enter about your profile and ideas and expectations in the 5G PPP online brokerage service, that will be made available in May at the same time as 5G PPP Call 2 opens.

In addition a complementary cartography of SMEs within the 5G value chain will be discussed at the next SME WG telco.
